1. 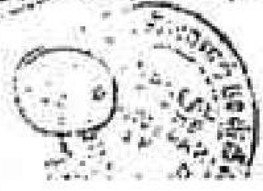

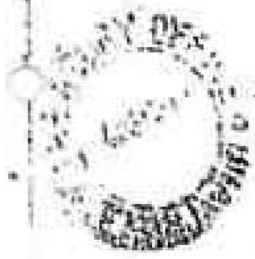

5. The Trustees shall and will stand possessed of any of properties whether movable or immovables which the Trustees may from any other source from time to time receive as donations, bequests or from any other source whatsoever for augmenting the fund of the Trust for the purposes connected with the object of the Trust not calculated to impede the due working of the Trust and also of any investment for time being representing the same herein after referred to as 'TRUST FUND' and also the net income of the Trust Fund into Trust.

6. The Trust shall be managed by a Board of Trustees consisting of not less than seven Trustees. All the first three Trustees mentioned in Clause (2) shall hold office for their lives unless they resign on their own accord or removed in.

7. Sri L. KAMAL BATCHA will be the Managing Trustee who will attend to the day-to-day administration of the Trust.

8. Mr. K. Mujibur Rahman the Trustee shall maintain regular books of account for the money, properties, or income and expenditure of the Trust.

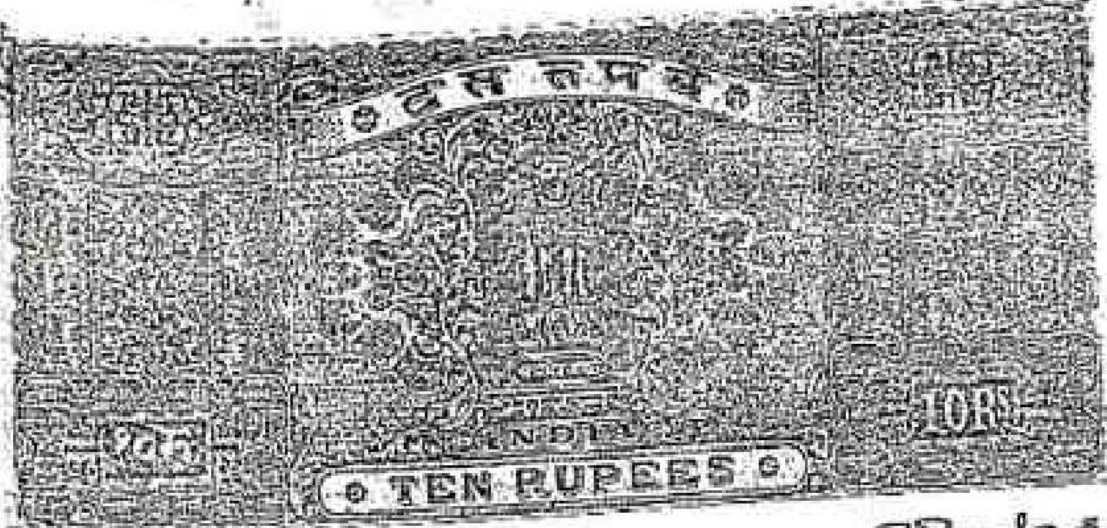

9. In case of vacancy arising out of resignation, removal or death of any Trustees, the other trustees shall Co-opt/ elect/ appoint a trustee in his or her vacancy who continues to hold all the privileges and duties of the Trustee. If the vacancies remain unfilled for more than two months, and/or if the vacancies are more than two, then the remaining trustees or any one of them will be at liberty to move the other Trustees and have the vacancies duly filled in by co-option, at their trustees meeting held for this purpose.

10. The affairs of the trust shall be decided and managed by the Board of Trustees who will hold atleast four Board Meetings in a year to manage and decide the affairs of the Trust. All decisions will be carried out as per opinion decision made by majority of members. All minutes of meetings will be recorded and signed by the Trustee in a Minute Book. The quorum for the Trust meeting shall be three, if for two successive meetings, quorum falls short, the members present shall from the quorum for the Third Meeting.
